# Requirements for ASPR's Hospital Preparedness Program



ASPR has allocated \$240M to 62 recipients for Fiscal Year (FY) 2024 of the <u>Hospital Preparedness Program (HPP) Cooperative Agreement</u> with a start date of July 1, 2024. Fiscal Year (FY) 2024-2028 requirements are beginning to be implemented, including requirements within Budget Period (BP) 1 due December 31, 2024 and June 30, 2025, respectively. Below, CONSTANT summarizes key information for the 318 U.S. health care coalitions (HCCs) to know about the updated HPP requirements. We also look forward to attending the <u>National Healthcare Coalition Preparedness Conference</u>, specifically the Administration for Strategic Preparedness and Response's (ASPR) *HPP New Five-Year Period of Performance* presentation presented by ASPR's Office of Health Care Readiness, to gain deeper knowledge of HPP activities.

- Overall Focus: The FY 2024-2028 HPP requirements seek to build on progress made within the FY 2019-2023 period of performance (PoP) and prioritize four (4) outcome areas: establish and act on multi-year priorities, enhance and sustain HCCs, coordination, and continuity of health care service delivery.
- **Key Changes:** The HPP Cooperative Agreement features more flexible and less prescriptive HCC membership requirements to allow for membership composition tailored

to unique needs. The "core" and "non-core" membership model is no longer in use, but HCCs must still maintain membership comprised of organizations from health care, emergency management, emergency medical services, and public health. Additionally, ASPR and the Centers for Disease Control and Prevention (CDC) worked collaboratively to include reciprocal language within the HPP and the <a href="Public Health Emergency">Public Health Emergency</a> Preparedness (PHEP) Cooperative Agreement. Furthermore, whole community planning is prioritized, as are activities in four (4) overarching activity groups: establish governance, assess readiness, plan and implement, and exercise and improve.

- New Requirements: The HPP Cooperative Agreement outlines activities that address emerging threats. This includes a requirement for a Patient Movement Plan and requirements for Cyber and Extended Downtime Assessments, Planning, and Exercises. Additionally, the Cooperative Agreement emphasizes coordination for health care readiness, requiring key partners for collaboration like educational agencies, state child care agencies, the State Unit on Aging, and community-based organizations. Finally, the Cooperative Agreement integrates some components from its previous iteration into larger requirements, like the Integrated Preparedness Plan (IPP) (formerly Multi-Year Training and Exercise Plan) being contained within the Strategic Plan, and has new requirements like an HCC Governance Document and Readiness and Workforce Assessments.
- Continued Requirements: Many requirements from the FY 2019-2023 PoP continue in this cycle, including the Continuity of Operations Plan, Response Plan, Hazard Vulnerability Assessment, and Medical Response and Surge Exercise (MRSE).



#### 12th Meeting of the Intergovernmental Negotiating Body
