#### FEMA Training and Exercise Support

CONSTANT supports curriculum development, sustainment, and management for FEMA's Qualification System (FQS), a set of metrics used to gauge capabilities for those deployed in incident management or support positions for disaster response and recovery. Over multiple contracts, CONSTANT has developed or revised more than 80 training courses, with deliverables including course materials, pre- and postcourse assessments, and Alpha Review and Beta Delivery Support. As part of Task Order 1, CONSTANT is developing an outreach and engagement strategy for ODRR external stakeholders, standardizing Field Operations Center (FOC) policies and procedures, developing and delivering mitigation materials and training to disaster survivors, and supporting strategic and leadership initiatives within ODRR.
