**We spotlight past performance across Emerging Threats:**

## Regional CBRNE Decontamination Program

CONSTANT implemented a multi-faceted program for the Bay Area to build regional CBRNE decontamination capacity. CONSTANT completed a capabilities assessment, informed by stakeholder workshops, online surveys, and a review of regional planning doctrine, that drove project execution and ensured that components addressed gaps outlined within the region's threat assessments. CONSTANT developed a Regional CBRNE Decontamination CONOPs, created a CBRNE-focused training plan, and hosted CBRNE trainings. CONSTANT also identified decontamination equipment for procurement by the region and hosted two drills with regional hospitals slated to receive the equipment. These efforts substantially bolster the Bay Area's readiness posture for CBRNE incidents.

## San Diego County CCTA Exercise

CONSTANT was contracted by San Diego County to coordinate a regional full-scale counterterrorism exercise involving play at three sites. The exercise involved over 1,200 participants from various agencies, the activation of the County Medical Operations Center, and the incorporation of major medical facilities. The exercise started with a simulated cascade of vehicle-borne and active shooter attacks. First responder agencies simulated their tactical response, securing incident scenes, neutralizing threats, and providing care to moulaged victims. Medical facility play fed off of on-scene elements, with hospitals coordinating with EMS for patient transport and managing medical surge. Other disciplines mobilized a Family Assistance Center.

## County Cybersecurity Plan, Training, and Exercise

CONSTANT worked with San Mateo County Health to craft a Healthcare Cybersecurity Plan and conduct a corresponding training and exercise. The healthcare coalition-level plan provides a common framework for responding to cyber threats impacting the County healthcare system by outlining the structures, systems, and processes necessary to execute an effective and coordinated response to a cyber disruption. A training was held to socialize the plan with coalition members, and the exercise allowed the healthcare coalition the opportunity to review and validate facility-specific operational and security procedures that guide information sharing, operational coordination, and decision-making during a cybersecurity incident.
