## FEMA Qualification System (FQS) Curriculum Development and Management

## SBA Disaster Recovery, Mitigation, Policy, Data Analytics

CONSTANT is leading a team in the execution of task orders on a \$50 million ceiling IDIQ for the SBA Office of Disaster Recovery and Resilience (ODRR). As part of Task Order 1, CONSTANT is developing an outreach and engagement strategy for ODRR external stakeholders as well as standardizing Field Operations Center (FOC) policies and procedures to streamline common processes.
