Statewide COVID-19 After Action Report

CONSTANT led the development of a COVID-19 AAR for the State of California. This AAR analyzes the State's response to the pandemic in areas such as response coordination, state guidance and policies, communication, logistics, social services, and economic relief. CONSTANT coordinated a multi-faceted data collection process that included documentation review and facilitation of hotwashes and interviews with representatives from all levels of government. The report positions California to strengthen preparedness for, response to, and recovery from future public health emergencies.

Regional Pandemic Preparedness Program

CONSTANT led the development of a comprehensive pandemic preparedness program for the Bay Area. The purpose of the project was to capture challenges and best practices identified during the COVID-19 pandemic and develop resources and capacity in the region to respond to and recover from a future pandemic health emergency. CONSTANT developed a suite of plans, trainings, and exercises to support both the region and individual jurisdictions. The project included focus on specific priorities for future regional consideration and advocacy.

County Public Health Exercises

CONSTANT planned, designed, coordinated, conducted, and evaluated San Mateo County Health's Rising Phoenix Full-Scale Exercise. The exercise was a chemical agent terrorist attack and active shooter scenario that required a coordinated, multi-agency response with jurisdictional partners. Objectives were aligned with Public Health Emergency Preparedness and Hospital Preparedness Program capabilities for exercise participants to achieve their individual exercise goals. CONSTANT has supported the County with its annual public health exercise series over several years and has also supported plan updates across disciplines.
