#### **County Medical Surge Plan**

CONSTANT worked with a California County to craft a Healthcare Surge Plan. The Plan outlines response and recovery actions to healthcare surge incidents that may exceed the day-to-day capacity of the County Public Health and Medical System. It serves as the foundation for mobilizing medical/health resources and coordinating with partners and support agencies in preparing for, responding to, and recovering from situations that significantly challenge the healthcare system. It ensures a coordinated response, resource allocation, patient management, and continuity of essential services during increased healthcare demands and integrates crisis standards of care indicators.

#### Statewide Disaster Behavioral Health Framework

CONSTANT crafted a Disaster Behavioral Health Framework for Arizona Health Care Cost Containment System (AHCCCS) that is designed to outline best practice considerations for advancing Arizona's future disaster behavioral health preparedness, response, and recovery. It is a blueprint to help communities integrate emergency management and disaster behavioral health resources. It is dual purposed in that the concepts outlined within the Framework are intended to aid Arizona's residents in holistic recovery and ensure that frontline responders are equipped with the emotional and psychological tools that they need following a disaster. The Framework also contains valuable resources for health education, hospital response planning, disaster resiliency, and meeting diverse community needs.

### **HCC Specialty Medical Surge Annexes and MRSEs**

CONSTANT has supported multiple healthcare coalitions with annual or performance measure requirements for the Hospital Preparedness Program cooperative agreement, including the Medical Response and Surge Exercise (MRSE) and the development of specialty surge annexes. We have developed surge annexes covering pediatric, burn, infectious disease, radiation, and chemical for multiple clients using an iterative, data-driven, and custom approach. We continue to work with healthcare coalitions as they develop, design, facilitate, and evaluate the annual MRSE that align with ASPR best practices.
