### Statewide Mass Fatality Training and Exercise Program

CONSTANT recently built a statewide mass fatality training and exercise program in California. The program provides solutions to lessons learned from recent mass fatality incidents, including wildfires and the COVID-19 response. The series includes 36 awareness, management, advanced, and executive training courses designed to enhance statewide capabilities, interoperability, and integration of technologies and best practices. Two tabletop exercises were held to test senior and executive-level command, followed by two statewide full-scale exercises to evaluate multi-jurisdictional response.

### Regional Pandemic Preparedness Program

CONSTANT led the development of a comprehensive pandemic preparedness program for the Bay Area. The purpose of the project was to capture challenges and best practices identified during the COVID-19 pandemic and develop resources and capacity in the region to respond to and recover from a future pandemic health emergency. CONSTANT developed a suite of plans, trainings, and exercises to support both the region and individual jurisdictions. The project included focus on specific priorities for future regional consideration and advocacy.

### Special Events Emergency Management Planning

CONSTANT has supported special events emergency management planning initiatives for the Los Angeles Region in advance of the FIFA World Cup™ and the 2028 Summer Olympics. This includes the development of a Gap Assessment and Improvement Plan and Special Events Emergency Management Coordination Planning Guide for Los Angeles County. It also includes serving as Special Events Emergency Management Coordinator for the City of Los Angeles, where we have convened a City Task Force and drafted a FIFA World Cup™ and Special Event Roadmap Template. We are also crafting a Special Events Gap Analysis. Furthermore, with Cal OES Office of Access and Functional Needs (OAFN), we developed an Integrating AFN Considerations within Large Stadiums Guide that provides stadiums with guidance and resources to integrate emergency plans to ensure the safety and security of all guests.
